## Military Equipment Annual Report for 2023

### Introduction

UC Riverside Police Department Policy 709 "Military Equipment" requires an annual report be submitted to the Regents and posted on the police department website for as long as the equipment is in use. This annual report is required to contain, at a minimum, the following information for the immediately preceding calendar year for each type of military equipment as classified in Government Code §7072:

1. A summary of how the military equipment was used and the purpose of its use
2. A summary of complaints or concerns received by the campus or department concerning military equipment
3. The results of any internal audits, any information about violations of the military equipment policy, and actions taken in response to those violations.
4. The total annual cost of each type of military equipment, including acquisition, personnel training, transportation, maintenance, storage, upgrade, and other ongoing costs, and from what source the funds will be provided for the military equipment in the calendar year following submission of the annual military equipment report
5. The quantity possessed for each type of military equipment
6. If the law enforcement agency intends to acquire additional military equipment in the next year and the quantity sought for type of military equipment

### *Section 1: Summary of How the Department Utilized its Military Equipment*

During 2022, the department did not deploy any of the equipment listed in categories 1-14. For reference, this includes the following department-owned items:

- a. Colt AR-15 Carbine Model LE6920 and Colt M4 carbine short-barrel rifle (the department's standard issue patrol rifle)
- b. Def-Tec/LMT 40mm Launcher
- c. FN Herstal 303 Launcher
- d. LRAD (Long-Range Acoustic Device)

*Section 2: Summary of Complaints or Concerns Received by the Campus or Department concerning Military Equipment*

The campus did not receive complaints or concerns about UCRPD's inventory or deployment of military weapons.

*Section 3: The results of any internal audits, any information about violations of the military equipment policy, and actions taken in response to those violations*

The campus did not receive any information or indication of a violation of the Military Equipment policy during 2022. The department did not identify any issues related to policy, training, or use of the designated equipment.

*Section 4: Total annual cost of possessing, maintaining, and acquiring the military equipment*

There were no deployments associated with our category 10 (specialized firearms and ammunition less than .50 caliber) and so there were no expenses related to that equipment during the reporting period. All costs related to the equipment's normal inspection and training are funded via the department's budgeted general funds.

In the reporting period, and pursuant to a request to the Regents of the University of California, the UC Riverside Police Department was able to purchase an additional six Def-Tec 40mm launchers, as well as an additional 60 rounds of ammunition for those launchers. These items are listed in Category 14 – Kinetic Energy Weapons and Munitions. The total cost to acquire these items was \$8,943.81.

*Section 5: The quantity possessed for each type of military equipment*

Current stock of military equipment during the reporting period is shown in the table below. Note that omitted sections (sections 1-9, 12) are not applicable to the UC Riverside Police Department as the department does not possess equipment in those categories.
