## Military Equipment Annual Report for 2025

### Introduction

UC Riverside Police Department Policy 709 "Military Equipment" requires an annual report be submitted to the Regents and posted on the police department website for as long as the equipment is in use. This annual report is required to contain, at a minimum, the following information for the immediately preceding calendar year for each type of military equipment as classified in Government Code §7072:

- 1. A summary of how the military equipment was used and the purpose of its use
- 2. A summary of complaints or concerns received by the campus or department concerning military equipment
- 3. The results of any internal audits, any information about violations of the military equipment policy, and actions taken in response to those violations.
- 4. The total annual cost of each type of military equipment, including acquisition, personnel training, transportation, maintenance, storage, upgrade, and other ongoing costs, and from what source the funds will be provided for the military equipment in the calendar year following submission of the annual military equipment report
- 5. The quantity possessed for each type of military equipment
- 6. If the law enforcement agency intends to acquire additional military equipment in the next year and the quantity sought for type of military equipment

### Section 1: Summary of How the Department Utilized its Military Equipment

During 2024, the department had a single deployment of the FN Herstal 303 launcher. This occurred during a mutual aid response by UCRPD officers to the UC Berkeley campus on May 6, 2024. Outside of a training environment, there were no other deployments of the department's military equipment as defined in Government Code §7072.

## Section 2: Summary of Complaints or Concerns Received by the Campus or Department concerning Military Equipment

The department received several complaints from community members at its annual public forum. These complaints centered around the possession of military weapons by the department in principle; none of the complaints communicated to the department focused on a particular piece of inventory or specific deployment in the 2024 calendar year.

# Section 3: The results of any internal audits, any information about violations of the military equipment policy, and actions taken in response to those violations

The campus did not receive any information or indication of a violation of the Military Equipment policy during 2024. The department did not identify any issues related to policy, training, or use of the designated equipment.

#### Section 4: Total annual cost of possessing, maintaining, and acquiring military equipment

The department has sufficient rounds in inventory to account for the single deployment of the FN 303 launcher and so there are no additional costs associated with that deployment. All costs related to the equipment's normal inspection and training are funded via the department's budgeted general funds.

### Section 5: The quantity possessed for each type of military equipment

Current stock of military equipment during the reporting period is shown in the table below. Note that omitted sections (sections 1-9, 12) are not applicable to the UC Riverside Police Department as the department does not possess equipment in those categories.
